



## ARTIST GUIDELINES, ACCEPTED WORKS AND EXHIBITION TERMS

Please review these guidelines as they contain important information for those wishing to show their work at YAA.

**ACCEPTED GENRES:** The York Art Association is a visual arts organization with a focus on fine art. Genres of work accepted for display

in the galleries include:

- DRAWING – ALL MEDIA
- FIBER ARTS – NON-FUNCTIONAL WALL HANGINGS, SCULPTURE
- HAND PULLED PRINTS
- MIXED MEDIA /COLLAGE
- PAINTING – ALL MEDIA
- PHOTOGRAPHY/DIGITAL PHOTOGRAPHY – ORIGINAL IMAGES ONLY
- SCULPTURE – ALL MEDIA, NON-FUNCTIONAL

*\*Size, framing, hanging devices and sculpture display policies apply \*Exceptions may be made for special invitational exhibits.*

### **REQUIREMENTS FOR ACCEPTANCE:**

- We will not accept work brought in early. If you cannot attend our intake days, please plan for a friend or relative to bring in your paintings.
- Paintings must be hand delivered to the premises and be signed in.
- Work must be completed in the past 3 years and is representative of artist's current or emerging artistic style. *Works displayed in other YAA exhibits is not permitted with exception of works entered into the annual open juried exhibition and Sally Little Danyo Members' Sales Gallery.*
- All paintings must be wired with gallery wire (twisted or braided, not single strand) for hanging. Saw tooth hangers, string or single thickness wire are not permitted.
- Paintings must be framed or have gallery wrapped canvas edges painted.
- Unless otherwise noted, size limitations are 48"x 60", including the frame. Diptych or triptych works must be displayed in a single frame to be considered one piece.
- Pick up dates are usually one-half hour after the close of the exhibit, and the following day and must be picked up by the artist or their representative. Please note: any work that is not retrieved by the last pick-up day is not covered by YAA insurance and may be disposed of without reimbursement to the artist. All efforts to contact the artist by phone and email will be made.
- The Rottler Award Selection Exhibit will be held every other year (odd years) and the Winners Exhibition will be in the even years. Winners will not be eligible to enter again for the following 2 selection years.
- Exceptions to these guidelines may be made at the discretion of the Gallery Committee.

**PROFESSIONAL VS. NON-PROFESSIONAL:** *(Some of our exhibits require entrance with these distinctions. In those circumstances, please refer to the following guidelines to determine which category you should enter.)*

- Artists who regularly sell and exhibit their work must compete within the Professional category, regardless of the awards they have won.
- Artists who have won any award in three exhibitions (honorable mention does not count) must enter the professional category for those exhibitions with such designations.
- Artists who provide classroom instruction in the fine arts must enter in the professional category.
- New members who do not meet any of the above criteria for the professional designation may choose the category in which they would like to exhibit. If their status changes to meet any of these criteria they must use the Professional designation.

**TERMS & CONDITIONS:** All SALES AND COMMISSIONS will be processed by YAA. Sales tax collected and payments made payable to YAA. Commission checks issued to artist within 30 days of the close of the exhibit. YAA retains a sales commission of 25% for members, and 30% for non-members. ARTWORK may not be changed, removed or added to prior to the close of the exhibit. If pickup cannot be completed during the designated schedule, YAA assumes no further responsibility/liability for the artwork listed below. It is the artist's responsibility to make pick up arrangements. **INSURANCE:** Artwork is not insured after pickup schedule has ended. Insurance value is designated by the "sale price" or "nfs value" listed by the artist. Further insurance is the responsibility of the artist. Artwork may be reproduced for marketing purposes by YAA.
